A complaint regarding damage of Efficycle ( Fabricated by Mechanical Department students for SAE competition) in college campus was received hence a meeting of discipline committee was called on 23/10/17 and 25/10/17 at 3pm in principal cabin, SVIT , Chincholi.

**Complaint Details :** On 15/10/2017 students from SAE (Society of Automotive Engineers) collegiate club 'PRAVARA HAWKS' were on college ground for conducting trial and shooting video of the trial of efficycle. The video was to be sent to SAE india officer. In the afternoon when students were out for lunch the efficycle was parked near security post. Instructions were given to security (Shri Gagare S. D.) by the students not to allow anybody to use the vehicle and not to even touch the vehicle. The vehicle was parked near security post near CCTV camera. But the security personnel itself were involved in taking ride of efficycle and thus causing damage to the vehicle due to improper handling and driving. To investigate the matter following persons were called and the observations are as under:

**Observations :**

1. Shri Gagare S.D (Security Personnel): Students Parked the vehicle at security gate near CCTV camera and told Shri Gagare not to allow anybody to drive or use the vehicle.
2. Shri Bhusal B.B (Security Officer) : He was the first to assemble the chain and drive the vehicle . But the vehicle was not damaged during his driving.
3. Shri Nirmal S.M. (Security Personnel): He was the next person to drive the vehicle. Shri Ratne V.B. ( Ladies hostel mess manager ) accompanied him for the round. The vehicle was damaged when these two persons were taking the ride. Shri Nirmal agreed his mistake.
4. Shri Ratne V.B. (Ladies Hostel mess manager): He said that he was forcefully asked to sit in the vehicle by Shri Nirmal for taking the ride.
5. Students : Mr.Gaurav Nisal and Mr. Mayur Mahajan members of SAE team said that apart from financial loss they have lost marks of the trial video which they were supposed to send. As the vehicle was damaged they could not send the video on time and also could not call SAE officer for inspection of vehicle.

**Evidence :** CCTV footage on 15/10/2017 between 3pm to 4.30 pm is available.













**Conclusion :**

1. Because of irresponsible behavior of the security personnel present at the security gate students have lost marks for the SAE event.
2. Students of SAE event had to get the vehicle repaired on urgent basis for which they had to spend Rs 20,000/- (Twenty thousand)
3. These expenses have to be borne by the concerned security people.

**Remarks:**

**Conclusion :**

**Complaint details :** Shri Bhusal B.B stays in guest house of our SVIT college. At night time @ 10 pm to 10.30 pm some canteen workers come to guest house with shri bhusal. They consume alcohol and order food from ladies mess. They also stay in guest house at night.

Shri Bhusal B.B. (Security) was called for investigation in front of discipline committee and following are the observations:

**Observations:**

1. Shri Bhusal B.B was asked to give explanation regarding the complaint received against him.
2. He agreed that he allowed three canteen workers shri Chitrasen, Shri Pintu and Shri Anil to stay in the guest house on 28 and 29/7/2017 (two days). As it was raining on these two days and canteen floor was wet with rain water Shri Bhusal allowed the above mentioned canteen workers to stay in guest house for two days.
3. Shri Bhusal B.B also agreed that it was his mistake that he didn't take permission from higher officials to allow those workers to stay in guest house.
4. But Shri Bhusal B.B disagreed that the canteen workers along with him drank alcohol in guest house or college premises.

**Conclusion :** Shri Bhusal B.B was found guilty of allowing canteen workers to stay in guest house.

**Remarks :** Shri Bhusal B.B is warned to follow the rules, regulations and Discipline of College. He is also warned and made to understand that Prior permission of higher officials is necessary to allow anybody to stay in college guest house.

A complaint regarding indiscipline was received against Shri Maruti Ghuge ( Driver) and Shri Gagare S.B. (security Personnel). Hence a meeting of discipline committee was called on 11/8/17 at 10.30 am in principal cabin, SVIT, Chincholi.

**Complaint Details :** On 29/7/2017 two girl students from ladies hostel were sick and wanted to go to doctor at Shinde hospital, Shinde palse (near Nasik Road). So Mrs Gadakh (Warden, Ladies hostel) called the driver shri Maruti Ghuge on night duty on 29/7/2017. Shri Maruti Ghuge(Driver) was drunk and accompanied by shri Gagare S.B (Security). Shri Maruti Ghuge drove the vehicle in drunk condition and had careless attitude while driving.

To investigate the matter following persons were called and the observations are as under:

**Observations :**

1. Above written complaint was given by Mrs Gadakh (Warden, Ladies hostel) to Principal of B.Pharmacy college.
2. Miss Kiran Vishvanath Patil and Miss Manjore Vrushali R.(Students of B.pharmacy college): According to written complaint and oral investigation Mrs Gadakh (Warden) called the night duty driver Maruti Ghuge at 10 pm on 29/7/2017 to take the students to doctor. But the driver arrived at @ 11.30pm. When Shri Maruti Ghuge came to take the students to doctor, shri Maruti Ghuge gave a bottle to Miss kiran (Student) and asked her to fill water and bring it back to him. When the student opened the cap of bottle to fill water she got smell of alcohol. Still she filled water and gave it back to Shri Maruti Ghuge. When the two girls sat in vehicle they understood by smell in vehicle that Shri Ghuge was drunk. So they told it to Mrs Gadakh (warden). Mrs Gadakh then requested security person to accompany them. So shri Gagare (security) accompanied them. They all returned back to college at @ 12 pm night. According to the statement of these two students, drivers of vehicle were found drunk earlier also and in spite of giving complaints no action was taken.
3. Shri Gagare S.D (Security Personnel): He accompanied the students to hospital but according to him he did not find driver was drunk.
4. Shri Maruti Ghuge : He disagreed that he was drunk on 29/7/2017 during duty hours at night. He said he had ate "Guthka" and said sorry for that.
5. Mrs Pawar S.B (Warden): On 10/8/2017 shri. Digamber Ghuge (watchman) and Shri Umberkar (Driver) came to girls hostel. They asked Mrs Pawar to send the two girl students to them. They wanted to speak something to the students. The students had exam the next day so they refused to come downstairs. Shri Digamber Ghuge and Shri Umbarkar came with

**Intension** to tell students that they should not tell anything against Shri Maruti Ghuge. But as they could not speak with concerned students they gave message about it to Miss S.S. Pawar.

**Evidence :** Vehicle Log Book was checked and found following things:

On 29/7/2017 at 7.22 pm Shri Maruti Ghuge went to drop Prof. Shirmatti and Prof. Gaudkar to Bank road and returned to college at 9.23 pm. A 50 kms run took around 2 hours as there was traffic jam and had to change his route and come to college.

At 10 pm Shri Maruti Ghuge was not available in college when warden called him to take the students to the doctor. According to Shri Gagare S.B.(security) Shri Maruti Ghuge went out of campus for dinner and returned at @ 11 pm. Shri Maruti Ghuge also agreed to it that as college mess was closed at 10 pm he went out of campus for dinner.

Shri Maruti Ghuge(driver) ,Shri Gagare S.B (security) , Mrs Gaudkar (warden) and the two girl students went to Shinde hospital at 11.23 pm and returned to college at 11.43 pm.

**Conclusion :**

1. Shri Maruti Ghuge was drunk and he drove the vehicle carelessly in such condition on 29/7/2017 as per statements of the two girl students and warden.
2. Shri Gagare S.B (security) did not note Shri Maruti Ghuge's entry in movement register at security gate. Also he did not find that Maruti ghuge was drunk. It appears that Shri Gagare S.B supports shri Maruti Ghuge.
3. The matter is considered very serious as people who are kept for security purpose are found supporting the indiscipline matters in campus.

Observations: Concerned Drivers and security personnel were called for investigation and details were noted as given below:

1. Mr.Bhise B.V (security personnel) : As per rules One person from security department always accompanies driver and bus to fill diesel in bus. On 3/7/2017 Mr Bhise B.V went to fill diesel in Bus no. MH 15 EF0036. Before filling diesel in bus two drums of 5 liters each were filled and kept aside by worker on petrol pump. Mr. Shaikh R.B who was present there for filling diesel in bus no MH 17 EF9062 took Mr. Bhise aside and asked Mr. Bhise for signing diesel register. Mr.Bhise gave a note about the happening to security officer on 7/7/2017.
2. Mr.Dethe T.S(security officer): He got the information from Mr. Bhise B.V and reported the same to Principal sir in writing on 7/7/2017.
3. Mr. Shaikh R.B. (driver Bus no MH 17 EF9062): was present there for filling diesel in bus no MH 17 EF9062. After filling diesel he started bus, but when he remembered that he has to collect diesel bill and oil can from the petrol pump he asked the worker of petrol pump to give it. Oil can was not available so he took the diesel bill, signed diesel register and after making entry in log book started for college. According to Mr Shaikh he was not involved in the diesel robbery matter.
4. Mr.Zade M.S. (driver Bus no MH 15 EF0036) : Initially he said that he is not involved in any kind of diesel robbery and has never done such kind of thing. But when video footage clip was shown to him in front of discipline committee, he readily agreed that he did the robbery of diesel.

Evidence: An evidence of the happening in the form of video camera footage was collected from Sarthak petrol pump, Mohu, by Prof. B.S.Vikhe (Vehicle Incharge) and submitted to Principal sir on 7/7/17. The video footage clearly shows how the diesel robbery was done.
